

Guidelines for Submission

National and International Academic Conference 2024 "Co-creation for Sustainable Development in Good Health and Well-Being" 12^{th} – 13^{th} September 2024 at Kantary Hotel, Nakornratchasima, Thailand

1. You can choose to submit an abstract or a full research manuscript

You may choose to submit an abstract or a full manuscript for publication in the form of E-proceedings. The abstract should be submitted in both Thai and English. The research work must be original, not previously presented at any national or international conferences.

3. Presentation Formats

- The work presented must be completed academic work that has not been previously published or presented at any other academic forum.
- E-Poster Presentation: Presented using MS PowerPoint. The content should be concise, with a clearly visible font size. The presentation should not exceed 5 minutes, with up to 2 minutes for questions, totaling 7 minutes per work.
- Oral Presentation: Presented using MS PowerPoint. The presentation should not exceed 10 minutes, with 2 minutes for questions, totaling 12 minutes per work.

4. Steps and Conditions for Presentation

- Prepare your work in the format specified by the academic conference. You can download the template and submit your work through the website Link: https://conf.suth.go.th/.
- Hospital personnel, students, medical staff, and the general public can register to present their work and specify the title of their work, subject to the following considerations and actions:
 - 1) Appropriate grouping and type of presentation.
 - 2) The presenter will be disqualified from presenting in the following cases:
 - 2.1) The work does not conform to the specified form or format.
 - 2.2) Failure to make revisions according to the experts' suggestions without a valid reason.
 - 2.3) Upon later verification, if it is found that the work has been previously published elsewhere in any form.
 - 2.4) The submitted work must pass a format compliance check. Prepared to present their work in person (onsite).
- *** In cases where you cannot present your work in person or fail to present it, your work will not be published or considered.

5. Criteria for Submitting Research Work

- The requirements for presenting work at the academic conference include works in health sciences, engineering, science and technology, management and business administration, information science, education, humanities and social sciences, social innovation, and other related fields. The work must not have been previously presented anywhere and must not be under consideration for publication or presentation at any other conference.
- Conditions/ Formats for submitting work: The original manuscript must be submitted for review by the expert committee. The selected works for both Oral Presentation and E-Poster must strictly adhere to the specified guidelines. If the submission is incomplete or incorrect, it will be returned to the author for correction before being sent to the experts for further review.
- Submit the original manuscript according to the conference's format by July 15, 2024.

6. Guidelines for Presenting Work in E-Poster Format

- You must submit the E-poster file in the specified format and within the specified time to allow the committee to review it and for attendees to view the E-poster later, with a provided link for access. The content of the poster should include an introduction, objectives, research methods, research results and discussion, recommendations, integration/application/utilization in regular work. The presentation time is 5 minutes, with a maximum of 2 minutes for questions. You can check the presentation schedule on the conference website at the link: https://conf.suth.go.th/.
- The E- Poster template can be downloaded from the website at the link: https://conf.suth.go.th/template.
- *** All participants who submit work will receive a certificate of participation in the academic conference via the email registered.

7. Guidelines for Oral Presentation

- Submitters must undergo a correctness check according to the specified format. The content
 of the presentation slides should include an introduction, objectives, research methods,
 research results and discussion, recommendations, integration/application/utilization in
 regular work.
- Submitters must arrive and register at least 15 minutes before the presentation time to prepare themselves. Presentations should be prepared using MS PowerPoint 2013 or later versions. If other programs are required, contact the staff at least 3 days before the presentation. Presentation time is 10 minutes, with up to 2 minutes for questions. The presentation schedule can be checked on the conference website at the link: https://conf.suth.go.th/.

- *** All submitters will receive a certificate of participation in the academic conference via the email provided during registration.

Abstract/Manuscript E-Proceeding:

Accepted works will be published. Authors must revise and correct abstracts or full research articles to meet the specified format requirements strictly. Incomplete or incorrect submissions will be returned for revision before publication. The works will be published in the form of electronic conference proceedings (E-proceedings) after the conference.

• Submission for Journal Publication:

If you wish to submit your original research article (manuscript) for publication in a recommended journal, you can send your manuscript to the respective journal. The evaluation criteria and publication process will follow the guidelines set by the journal's editor.
